## I. RIGHT OF WITHDRAWAL AND CHANGES

In accordance with § 16 (3) sentence 1 WpPG, investors who have already agreed to purchase or subscribe any Instrument before Supplement No. 1 of 21 August 2014 is published shall have the right, exercisable within two working days after the publication of this Supplement, to withdraw their acceptances, provided that the new factor, mistake or inaccuracy which is the subject of this Supplement arose prior to the final closing of the offer to the public and the delivery of the Instruments, § 16 (1) WpPG.

The mistake that leads to Supplement No. 1 of 21 August 2014 is a wrong figure in Section B. 12 of the Summary (Risk-weighted assets in € million, 31 March 2014). Pursuant to this mistake, the following changes were made.

## **CHAPTER I "SUMMARY"**

- 1. The second sentence of Element **A1** in "Section A. "**Warnings**" on page 5 of the Prospectus shall be deleted and replaced by the following:
  - "Any decision to invest in the Instruments should be based on consideration of the Prospectus as a whole as supplemented by any supplement thereto, including the registration document of Norddeutsche Landesbank Girozentrale of 14 August 2014 as supplemented by any supplement thereto by the investor."
- 2. The figure relating to "Risk weighted assets in € million" as of "31 March 2014" in Element **B.12**, in Section B. "**Issuer**" "regulatory key figures on page 9 shall be deleted and replaced by 68,930.

#### **CHAPTER I "ZUSAMMENFASSUNG"**

- 3. The second sentence of Element **A1**, Section A. "**Warnhinweise**" on page 26 of the Prospectus shall be deleted and replaced by the following:
  - "Der Anleger sollte jede Entscheidung, in die Schuldverschreibungen zu investieren, auf den Prospekt als Ganzen, einschließlich etwaiger Nachträge und einschließlich des Registrierungsformulars der Norddeutsche Landesbank Girozentrale vom 14 August 2014, einschließlich etwaiger Nachträge hierzu, stützen."
- 4. The figure relating to "Risiko gewichtete Aktiva (in Mio. €)" as of "31. März 2014" in Element **B.12**, Section B. "**Emittentin**" "Regulatorische Kennzahlen" on page 30 shall be deleted and replaced by 68.930.
